#### Mayor Weinberger Appoints VCW Commissioner Kerin Durfee as New Director of City Human Resources Department

Kerin brings over 20 years of management and recruitment experience, as well as extensive organizational development expertise to the role. Kerin currently serves as Director of Earned Revenues at ECHO Leahy Center for Lake Champlain. Previously, she worked as Front End Manager at City Market and as a Recruitment Specialist for the Human Resources Department at Price Chopper/Golub Corporation. "I am excited to be appointing Kerin as the City's next HR Director," said Mayor Miro Weinberger. #### VCW (Un)Equal Pay Day Video Podcasts

With our new video podcast series, VCW hopes to raise awareness about pay equity, and the ways racism, sexism, homophobia, and ableism intersect, creating much larger wage gaps for women of color, members of the LGBTQIA+ community, and women living with disabilities.

The first premiered on <u>Asian American and Pacific Islander women's (un) equal pay day, March</u> <u>9th</u>, and featured a conversation with Bor Yang, director of the Vermont Human Rights Commission, Senator Kesha Ram, and VCW Chair Lisa Senecal.

The next conversation launched on <u>all women's (un)equal pay day March 24th</u> and focused on the ways COVID-19 impacts decisions that women and their families are making. Guests included Lara Scott, the director of Mobilization of Volunteer Efforts at Saint Michael's College, and Sarah MacDonald, assistant director and classroom educator at the Early Learning Center in Colchester. VCW Commissioner Kellie Campbell moderates.

#### Menstrual equity bills are moving

The House passed <u>S.53</u>, which would eliminate the sales tax on mensutral supplies. The House added unrelated language to this bill, and we're watching to see what approach the Senate will take. Learn more about this from a <u>recent VTDigger article</u>.

<u>S.115, a miscellaneous education bill</u>, includes a provision to require schools serving grades 5-12 to provide menstrual supplies in restrooms. The bill has been passed by the Senate and is now being considered in the House. <u>Let your representatives know if you support this proposal</u>.

#### Senate passes ban on LGBTQ+ 'panic' defense

Today, the Senate gave it's final approval to <u>H.128 limiting criminal defenses based on victim</u> <u>identity</u>, banning the use of evidence of the defendant's discovery, knowledge, perception, or belief about a crime victim's actual or perceived sexual orientation or gender identity.

### Senate approves state constitutional amendments on slavery, abortion rights - VTDigger

"Two proposed amendments to the Vermont Constitution were approved Friday by the state Senate: one to protect abortion rights, and the other to clarify that slavery and indentured servitude are prohibited 'in any form.' The proposals were approved by the House and Senate in 2019. Constitutional amendments need to be approved by two separately elected Legislatures before they can be placed on the ballot for voters to decide." – <u>Xander Landen for</u> <u>VTDigger</u>

## Madeleine Kunin: Finally, a big step forward on financing child care

"[The Vermont Legislature] recently approved a bill, <u>H.171</u>, that states no family receiving subsidized child care would have to spend more than 10 percent of their gross annual income on child care. The price tag was \$12.4 million in state and proposed federal funds. The vote was an astounding 146 to 1. The bill flew by because legislators had learned that women who could not find child care had to stay home to care for their kids. A nice luxury for some, poverty for most. Those so-called 'women's issues' are now essential economic issues that have gained wide support. Access to child care can make the difference for a family, whether it slips into poverty, or holds on to the middle class." - <u>Madeleine Kunin via VTDigger</u>

### Green: Interstate Nurse Licensure Compact offers flexibility | VTBusiness Magazine

"Last week, the House Government Operations Committee took testimony on S.48. The Interstate Nurse Licensure Compact is an important health care workforce initiative and a key recommendation from the Rural Health Services Task Force 2020 Report. Under the compact, nurses can apply for a license in one compact state and have access to all the other compact states without applying for separate licenses, which is an appealing option for new graduates. Maine and New Hampshire are currently compact states and New York and Massachusetts have bills pending in the legislature. In addition to VAHHS, other supporters of the bill include the Office of Professional Regulation, Board of Nursing, American Nurses Association-VT Chapter, Organization of Nurse Leaders, and a coalition of health care provider organizations including the long-term care facilities, home health and hospice agencies, federally qualified health centers (FQHC) and others." - <u>Devon Green via Vermont Business Magazine</u>

### New Reach Up rental assistance program to launch in April | VT Business Magazine

A new Reach Up Emergency Rental Assistance (RUERA) program assists families with back and future rent for up to 15 countable months. This program is launching in early April for families enrolled in any Reach Up program with at least one parent who receives Social Security Income (SSI). Reach Up programs include traditional Reach Up, Reach First, Reach Ahead, Reach Up's Post-Secondary Education program (PSE), and Reach Up Child-Only households. RUERA has been made possible through federal funding. To apply for the program, a Reach Up enrolled family can access the application online.

### Prison proposals would close women's facility, but expand corrections capacity | VTDigger

"A consulting firm hired to examine Vermont's corrections system has proposed five plans for redesigning it in the coming years — all of which involve closing the state's only prison for women. The proposals, presented to legislators Tuesday, would increase the number of beds in the state's prison system to more than 2,000. It now has just under 1,800 beds, though the use of about 400 is restricted. The contractor, HOK Group, recommended shutting down the Chittenden Regional Correctional Facility and replacing it with a new women's prison. The aging complex is deteriorating and has been criticized for unsanitary conditions. Lawmakers have already started planning to replace the South Burlington facility...

In a statement issued Wednesday, the ACLU of Vermont said that HOK's proposals disregarded 'years of hard work across our system that safely reduced the prison population by hundreds of people.' Falko Schilling, a lobbyist for the group, wrote, 'It is baffling that this proposal envisions locking up 500 more people without justification when all the trends are in the opposite direction and the evidence is clear that we can and should imprison fewer Vermonters.' <u>-Xander Landen for VTDigger</u>

### Vermont Conversation: Journalist Eva McKend blazes trails from Vermont to D.C. | VTDigger

Journalist Eva McKend is a trailblazer. She was the only Black, female, on-air news anchor in Burlington when she worked at Vermont's CBS affiliate, WCAX, from 2015 to 2018. And she was

among a small number of journalists of color in the state. In 2018, McKend moved to Washington, D.C., to become an on-air congressional correspondent for Spectrum News, a cable news service. McKend, a graduate of Swarthmore College and the Newhouse School of Public Communications at Syracuse University, is a regular guest on the NPR program 1a, and her series of stories on Black hemp farmers in Kentucky has won several awards. <u>McKend spoke</u> with David Goodman on the Vermont Conversation last week.

### Frustrated with one local newspaper, prominent Charlotte journalists help start another | VTDigger

"After residents cried foul over a local reporter's resignation from Charlotte's nonprofit newspaper last month, a group of nationally known journalists who live in town are starting a news outlet of their own. Chea Waters Evans, who quit as editor of The Charlotte News in March under mounting pressure from the paper's publisher, will serve as editor-in-chief of the newly minted publication, The Charlotte Bridge. Its board of directors will include four prominent journalists who left the Charlotte News board in protest of Evans' treatment there. The Bridge — a weekly, all-digital, nonprofit publication — promises 'fact-checked, fearless, fair journalism' for the town, according to its website." – James Finn for VTDigger

### New bill would create fund to help BIPOC Vermonters own land | VTDigger

"Throughout Vermont's history, racist practices made it difficult or impossible for Black, Indigenous and other people of color to own homes and land. Today, 97.7% of Vermont farms are white-owned. White Vermonters have a home ownership rate of 72%, compared to 24% for Black Vermonters. And in Burlington, Black residents are four and a half times more likely to be denied a home loan than their white counterparts. Those statistics are a direct result of Vermont's history of systemic racism in housing and land ownership, activists say. And now, they're pushing legislation that would begin to combat those centuries-old disparities. H.273 would create the Vermont Land Access and Opportunity Fund to promote racial and social equity in land access and property ownership. It would do so through grant programs, financial education and other investments targeted to Vermonters who have historically been discriminated against." – <u>Ellie French for VTDigger</u>

## 1st director of equity appointed in Winooski, Vermont's most diverse city | VTDigger

"The Winooski city government has hired its first director of equity. Yasamin Gordon will start her new job May 10, the city announced Thursday. Gordon previously worked for the Champlain Valley School District as a lead diversity, equity and inclusion coach, and for Shelburne Community School as the planning room director. Now, she'll be reviewing local policies and connecting historically marginalized groups to resources and services in an effort to improve equity in Vermont's most diverse city." – <u>Seamus McAvoy for VTDigger</u>

## Legislators want new data system to understand where racial disparities begin | VTDigger

"Dealing with systemic racial disparities is a major theme in the Legislature this year. However, despite multiple proposals, there's one big problem: The state doesn't have the data it needs to figure out where inequities begin. A new bill is trying to change that by establishing a Bureau of Racial Justice Statistics, with a related advisory panel, to find out where the racial disparities are in Vermont's criminal justice system and how to address them. "Not having this information leads us to making wild speculations sometimes," said Sen. Dick Sears, D-Bennington, chair of the Senate Judiciary Committee." – <u>Ellie French for VTDigger</u>

## Vermont National Guard severs ties with guardsman accused of sexual assault | VTDigger

"Daniel Blodgett is no longer a member of the Vermont National Guard nearly a month after Seven Days reported on his extensive criminal record and allegations of sexual assault and violence. At a meeting of the House Committee on General, Housing and Military Affairs on Thursday morning, Adjutant Gen. Greg Knight informed lawmakers of Blodgett's status as Knight presented an annual report on sexual harassment and assault in the Guard." – <u>Ellie French for VTDigger</u>

Safe Art will offer <u>Youth Wellbeing Project: Mindfulness, Creativity, & Social Justice Camp</u> for ages 8-14.
