Report documents pattern of sexual abuse at Vermont's only prison for women | VTDigger

"A monthslong investigation into sexual misconduct at the Chittenden Regional Correctional Facility uncovered a 'disturbing degree' of abuse at the women's prison, a year after Seven Days reported the allegations.

The Vermont Agency of Human Services contracted the law firm Downs Rachlin Martin to conduct the probe after the initial allegations caused an outcry last December. The firm released a 60-page summary of its findings on Wednesday.

While the investigation did not offer conclusions on the veracity of any particular allegation, it did find that reports of chronic sexual abuse at the facility were "largely accurate," Tristram Coffin, the director of Downs Rachlin Martin and a former U.S. Attorney, said at a press conference Wednesday. It also found more limited instances of substance abuse by staff at the South Burlington prison.

'It would have been of significant concern if DRM had encountered even one allegation of sexual misconduct involving a staff member and a resident,' the report reads. 'Instead, DRM encountered many such allegations.'

Through a review of personnel files and months of interviews with prison staff and residents, investigators said they discovered an "extremely troublesome" pattern of misconduct. The report documents incidents of sexual abuse perpetrated by

corrections officers both against residents and against fellow employees."- [Katya Schwenk for VTDigger](#)

Health concerns linger at women's prison after judge declines to act on unsanitary conditions | VTDigger

"In a ruling last week, a Vermont Superior Court judge dismissed complaints brought by a woman incarcerated at the Chittenden Regional Correctional Facility about unsanitary conditions in the prison's showers....'It's very hard to get courts to grant prisoners relief from conditions that I think the public wouldn't accept if they were aware of them,' said Kelly Green, a defense attorney with Vermont's Prisoner's Rights Office who represented Conte at trial." - [Katya Schwenk for VTDigger](#)

New Vermont Addiction Recovery Program Set to Expand Services | NECN

A new sober living facility, [Jenna's House](#), opened recently in Lamoille county for women who have complex histories of trauma seeking recovery. Sober housing, treatment services, a support community, and an innovative work program that provides job skills are part of the wrap-around services offered. The Tatro family began Jenna's Promise in 2019 after the tragic loss of their daughter to substance use disorder. Inspired by their daughter's spirit and her desire to help, [this project "was created to combat this disease and help those who are struggling with addiction and their families heal."](#)

BIPOC Business Survey Preliminary Results | Vermont Partnership for Fairness & Diversity

Vermont Partnership for Fairness & Diversity released the preliminary results of its BIPOC (Black, Indigenous, and People of Color) Business Survey. Seventy-five (75) BIPOC business owners from ten counties operating in thirteen different business sectors completed the survey. [Survey results, findings, and recommendations are posted to the Vermont Partnership website.](#)

The survey was designed to gauge interest in the creation of an entity to serve the needs of BIPOC business owners in Vermont. Sixty-two percent (62%) of BIPOC business owners responding to the survey were not members of a chamber of commerce or business association. Over three quarters (76%) felt a need for a government commission to promote and support the growth of BIPOC businesses. Access to capital ranked highest on the list of priorities for BIPOC business owners, followed by the need for a mutual support network.

State data shows frequent use of psych patient restraints |

"Restraint and seclusion are used just as frequently on psychiatric patients who choose to get inpatient mental health care at the Brattleboro Retreat as those who go to the hospital involuntarily. It's the first time the state has collected use-of-force data for voluntary patients, who make up about two-thirds of Vermont's mental health patients. Between Oct. 1 and Nov. 9, Brattleboro Retreat employees restrained, secluded or forcibly medicated voluntary patients 79 times. That's compared to 86 instances with involuntary patients." – [Katie Jickling for VTDigger](#)

New data shows Burlington police used force against Black individuals at record rate in 2020 | VTDigger

"In total, the Burlington police used force against 149 people in the first 10 months of 2020. That figure is lower than in previous years, continuing an apparent downward trend in the number of use-of-force incidents — but arrests and calls for service have been far fewer in 2020, which officials attribute in part to the pandemic. Of the 149 people who were subjected to force, more than 28% were Black. Black residents comprise only 6% of Burlington's population, according to last year's Census Bureau estimates. The disproportionality of that rate is higher than any recorded in the past eight years. Between 2017 and 2019, about 26% of subjects of police use of force each year were Black; in 2012, it was 18%." - [Katya Schwenk for VT Digger](#)

'Not The Problem Of The Oppressed': Incoming Rutland NAACP President Talks Priorities, Exposure | VPR

The Rutland branch of the NAACP will soon have new leadership. Mia Schultz is poised to take over as president of the organization, as its founding leader, Tabitha Moore steps down. The NAACP has advocated for civil rights nationally since 1909, but the Rutland branch has been in operation for just about four years. It boasts 550 members, making it the second largest chapter in New England. In addition to her new role, Mia Schultz is also on the board of the advocacy group Rights & Democracy and is the chair of the Bennington Town Democratic Party. Proposed fund would help Black, Indigenous and people of color buy property | VTDigger

"White people own most of the land in the state, said Steffen Gillom, president of Windham County Vermont NAACP. Only eight farms in Vermont are fully owned by Black people, according to the American Farmland Trust.

Community leaders of color are about to ask the Legislature to establish a fund to help Black, Indigenous and people of color to buy a home, land, or a farm. Gillom has worked with Rep. Brian Cina, P-Burlington, and Kenya Lazuli, cofounder of Radical Imagination, among others, to draft the proposal." – [Amanda Gokee for VTDigger](#)

New KIDS COUNT report identifies critical priorities for Vermont's pandemic response | Annie E. Casey Foundation

[Kids, Families and COVID-19: Pandemic Pain Points and a Roadmap for Recovery](#), a new national report of recent household data from the Annie E. Casey Foundation, was released today. Based on data from the US Census Bureau's Household Pulse Survey, the report's findings illustrate the compounding impacts of the pandemic crisis on the lives of children and families and highlight the need for decisive action from policymakers that prioritizes equitable solutions to help families survive the

catastrophe.

Poll: Vermonters Support More State Funding For Child Care | VPR

“A new poll commissioned by one of the state’s leading child care advocacy organizations shows broad public support for increased state funding for Vermont’s child care system. Aly Richards, CEO of Let’s Grow Kids, says the coronavirus pandemic has presented the most compelling case yet for new public investments in Vermont’s child care infrastructure. And she said a survey of 500 Vermonters conducted last month indicates the public is on board with increased state appropriations. The poll found that 78% of respondents favor increasing state funding to ensure ‘there are enough affordable, high-quality child care programs in Vermont for children under age five.’” – [Peter Hirschfeld for VPR](#)

Bridging the Skills Gap: Career and Technical Education in High School | U.S. Department of Education

[The Department of Education has released a data story](#) exploring access to and participation in career and technical education (CTE) in high school, as well as outcomes of students who concentrate studies in CTE. The data shows that female students and students of color are less likely to participate in CTE, and less likely to concentrate in CTE. Vermont has lower than average CTE concentrations in high school, compared to other states.

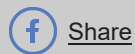
