New Video Podcast, (un)Equal Pay Day Podcast Series | Vermont Commission on Women

Today marks the day into 2021 that the average American woman must work to catch up to the wages earned by the average American man in 2020.

Based on median earnings for full-time, year-round workers, women are paid 82 cents for every dollar paid to men. Vermont Commission on Women (VCW) launched the second in a series of Equal Pay Day video podcast conversations today, March 24th, the day into the year women need to work before their earnings catch up to those of men in 2020 due to the wage gap.

This podcast conversation centers on the ways COVID-19 impacts decisions that women and their families are making. It touches on career choice and advancement, including occupational segregation. It explores the critical role of women as essential workers and as early care and education providers in keeping women in the workforce, while calling attention to how their worth is not reflected in earnings or status. Guests recount personal stories reflecting on the challenges and gifts of this time as women working in Vermont. The podcast concludes with a

hope-filled discussion about this unique opportunity to reconstruct and rebuild systems back to be more equitable.

Guests on this podcast include educator Lara Scott, the director of Mobilization of Volunteer Efforts (MOVE) at Saint Michael's College, and Sarah MacDonald, assistant director and classroom educator at the Early Learning Center in Colchester. The conversation is introduced by VCW's executive director Cary Brown and moderated by VCW Commissioner Kellie Campbell, Chair of VCW's Education and Human Development committee.

This podcast addresses equal pay day and the wage gap for all women in the U.S. VCW's first podcast launched March 9, Asian American and Pacific Islander women's equal pay day, and featured a conversation with Bor Yang, director of the Vermont Human Rights Commission, Senator Kesha Ram, and VCW Chair Lisa Senecal. As the year progresses VCW will produce episodes marking equal pay days for mothers on June 4, for women living with disabilities on June 13, for the LGBTQIA+ community during national Pride month on June 28, for Black women on August 3, for Native American women on September 8, and for Latinas on October 21.

With these video podcast conversations, VCW hopes to raise awareness about pay equity, and the ways racism, sexism, homophobia, and ableism intersect, creating much larger wage gaps for women of color, members of the LGBTQIA+ community, and women living with disabilities.

Menstrual Equity Update | Vermont Commission on Women

VCW has updated our <u>info sheet about access to menstrual supplies</u> to include <u>S.115</u>, an act relating to making miscellaneous changes in education laws. This act now includes a provision that would require public schools in Vermont who serve grades 5 - 12 to provide menstrual supplies for free in student restrooms. It is being considered by the <u>House Committee on</u> <u>Education</u>. Share your thoughts about this provision with the Committee and with your representatives.

(Lack of) Paid Leave Story Collection | Vermont FaMLI Coalition

The Vermont FaMLI Coalition is collecting stories that highlight the critical need for a permanent federal solution to Paid Family and Medical Leave. From individuals, parents, grandparents, children, child care providers, health care workers, social works, the ripple effects of the lack of paid leave are far-reaching, and each story will help paint a more cohesive picture.

Well-Woman Chart | Women's Preventive Services Initiative

Developed by the Women's Preventive Services Initiative, a federally supported collaborative program led by the American College of Obstetricians and Gynecologists, the <u>Well-Woman</u> <u>Chart</u> provides women information about preventive health care services recommended for their age group. The Well-Woman Chart is updated each year and available in both interactive or print versions. Women can use it to prepare for their annual checkup appointment, knowing what health screenings they may need and gathering questions they might want to ask their healthcare provider.

Molly Gray: Vermont women are in economic crisis. The Family Act is a solution | VTDigger Commentary

"It is true that the pandemic has been devastating, but working people in Vermont — especially women — have long been caught between their work and caregiving. Covid-19 has laid bare our country's failure to support the economic well-being of working families and women, and it is past time we address this through effective legislation that is affordable for employers of all sizes. The good news is there's a national solution that would address Vermont's paid family and medical leave crisis head-on: The Family And Medical Insurance Leave (FAMILY) Act introduced in the U.S. House of Representatives and Senate. The federal <u>Family Act</u> would provide Vermonters with 12 weeks of paid leave to recover from illness, care for a sick family member or recover from childbirth."

Vermont Legislative Research Service | UVM

Key child care reform bill moves forward in Vt. House | WCAX

"Pugh says it allocates \$5.5 million next year to the state's child care program for low-income families, expanding who is eligible for benefits. That money will also allow the program to put a cap on how much families with multiple children have to pay for child care. Second, the bill provides \$1.8 million for providers to pay off student loans and another \$700,000 for scholarships. 
